52.212-4 (o) (TAILORED) (FEB 2007)

Warranty. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract. In the event that the terms of the contractor's standard commercial warranty (See Clause 552.246-73 Warranty—Multiple Award Schedule) conflict with the warranty terms contained in this clause, the terms of this clause will govern this contract, unless some other resolution is specified in the award document.

52.212-4 (p) (TAILORED) (FEB 2007)

Limitation of liability. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government in a breach of warranty action for consequential damages resulting from any defect or deficiencies in accepted items. In the event that the terms of the contractor's standard commercial warranty/limitation of liability clause (s) place greater limits on the contractor's liability than do the terms contained in this clause, the terms of this clause will govern the contract.

552.246-73 WARRANTY— MULTIPLE AWARD SCHEDULE (MAR 2000)

- A. Applicable to domestic locations. Unless specified otherwise in this contract, the Contractor's standard commercial warranty as stated in the Contractor's commercial price list applies to this contract.
- B. Applicable to overseas destinations. Unless specified otherwise in this contract, the Contractor's standard commercial warranty as stated in the commercial price list applies to this contract, except as follows:
 - 1. The Contractor must provide, at a minimum, a warranty on all non-consumable parts for a period of 90 days from the date that the Government accepts the product.
 - 2. The Contractor must supply parts and labor required under the warranty provisions free of charge.
 - 3. The Contractor must bear the transportation costs of returning the products to and from the repair facility, or the costs involved with Contractor personnel traveling to the Government facility for the purpose of repairing the product onsite, during the 90 day warranty period.

RETURNED GOODS POLICY

Before any item may be returned, the customer must first obtain an authorization from Hutchins & HutchinsSM. Notification of discrepancies in shipment must be made within 12 hours of receipt of merchandise. Requests cannot be on orders exceeding 30 days from the invoice date. Hutchins & HutchinsSM will not accept product that is older than 6 months from the date of receipt. For non-defective merchandise, a 15% handling plus 10% restocking charge will be assessed on the selling price of all merchandise returned. If return is authorized, to insure proper adjustment, customer is required to provide Hutchins & HutchinsSM with the following information:

- Customer's name and address as it appears on the invoice
- Customer's purchase order number. Hutchins & HutchinsSM invoice number and date
- Hutchins & HutchinsSM shipping order number
- The quantity, description, catalog number & reason for return.

The customer must coordinate with a representative of Hutchins & HutchinsSM concerning method of shipment, special labeling and packaging requirements.
